11. Contractual obligations of connecting to North Pole Utility System

1. I, the applicant, understand and agree that I will furnish all labor and materials and pay for all costs necessary to make connection (tie-in) to the City’s utility system.
2. I, the applicant, agree to adhere to the City of North Pole’s Service Line Standards in reference to the materials needed for the tie-in to the City’s utility system.
3. I, the applicant, understand that I will bear the expense necessary to correct any deficiencies or make repairs caused to the City’s utility system by my tie-in.
4. I, the applicant, understand that I am responsible for all maintenance and repairs with respect to the portion of the line which extends from the City’s main(s). See North Pole Municipal Code, 13.16.020.
5. I, the applicant, understand and agree that the City of North Pole shall have access to my property at all times necessary for the purpose of inspecting the water and sewer tie-in on my property; to repair the City’s water and sewer distribution system; and to disconnect and/or shut off utility service in the event the utility account becomes delinquent.
6. I, the applicant, or my agent, agree to verify the presence of other utilities or underground articles in the excavation area including, but not limited to, telephone and electrical utility lines.
7. I, the applicant, or my agent, shall be responsible for all damages to persons or property that occur as a result of fault or negligence in connection with the prosecution of the work and shall hold the City harmless.
8. I, the applicant, agree to pay all water and sewer charges as prescribed in Chapter 13 of the North Pole Municipal Code. The City shall have a secured interest in the above referenced property for payment of all utility bills and charges that may arise under the City of North Pole Code of Ordinances.
9. If a Highway Park Subdivision property owner, I have received a copy of resolution 98-29.

- A minimum of 48 hours notification is required to schedule a water main shutdown and inspection by the North Pole Utility Department.
- All work MUST be inspected by the North Pole Utility before water service is returned to the main and the work is covered. Work not inspected by the North Pole Utility before it is covered shall be re-excavated for inspection.
- The following must be attached to this application (see NPMC 13.16.020).
 - * Alaska Business License and City of North Pole Business License for contractor’s performing work.
 - * Proof of commercial general liability insurance for all operations performed by the contractor on an occurrence basis against claims for personal injury; bodily injury; death and property damage, including loss of use.
 - * Proof of workman’s compensation insurance, if required by law.
 - * A work plan including a work schedule.
 - * Other proof of capability to perform such work as required by the North Pole Utility.
